This much valued event not only involves our town residents, but has a wider appeal in the surrounding area. In addition to its social value it also has an economic benefit to local businesses. To secure the future of the Dickensian Evening the Council wishes to show its support for this event by increasing the annual grant from £500 to £1,500, which was the level of total grant which was previously achieved.
