79. Reaffirmation of the Armed Forces Covenant – Receipt of the covenant had been acknowledged and registered.

83. 29 i) Market Place Update – The planters and bench seats were due for delivery within the next two weeks.

92. Update re quotes from highway engineers for Market Place western end pedestrianisation scheme – No quote or estimate had been received from other highway engineers. The only estimate received had been from Glanvilles for $\pounds 18,800$. As agreed at the previous council meeting, Glanvilles had been instructed to proceed with arrangements for permanently pedestrianising the Market Place western area.

11. HOSC meeting follow up – To consider seeking the reopening of the Community Hospital inpatient beds through legal processes.

The patient beds at the hospital had been temporarily closed in 2016. The issue that had caused this had been resolved in September 2020. Although HOSC on a number of occasions had requested that the beds be reopened, they remained closed. At the HOSC meeting the CCG advised it was intending to conduct a study to determine whether the beds were required. The study was estimated to take 17 months to complete.

To declare that an emergency situation exists, where the Town Council is unable to conduct its business through meetings due to the Coronavirus restrictions being in place and the conducting of meetings online not being permissible, Section 26 of Standing Orders "Emergency Consultation Panel" (see below) will apply until the emergency is over.

"26. Emergency Consultation Panel"

In circumstances where the Town Council is unable to conduct its business through meetings due to a national emergency, or a similar situation, standing orders shall be suspended and the Clerk, as the Council's Proper Officer and Responsible Financial Officer shall be given delegated authority to make decisions on the Council's behalf, subject to the agreement of an Emergency Consultation Panel (ECP). The members of the ECP shall be the Town Mayor and the chairmen of the standing committees. The Clerk will be guided by the views of a majority of the ECP. During the period in which these circumstances pertain, the Clerk will have the same authority level as the Council itself."
