The purchase had not yet been signed off by the District Council's Senior Team. The aim was to have the new cameras installed by the end of the financial year. Permission was being sought from Oxfordshire County Council to install the camera on a lamp post in Wallingford Street.

14. Civil Parking Enforcement.

a) To identify areas where priority should be given to enforcement.

It was agreed that the following areas should be given priority:

Newbury Street to the junction with Church Street, Portway, Church Street, Mill Street and western end of Market Place.

b) To identify areas where parking restrictions should be changed:

- 1. Grove Street (Area C on map) change current single yellow no waiting Mon-Sat 9am-5pm section on northern side to residents parking zone. Retain all other restrictions in Grove Street. Reason: to mitigate future parking issues under CPE for residents (Note that although in theory residents could obtain parking permits from the Vale for the Beacon car park, in practice all available permits are already issued).
- 2. Wallingford Street (Area P on map) section on south side between Partridge Close and Rowes/Costcutter which is currently no waiting Mon-Sat 8am-6pm should become limited waiting for 30 minutes no return within 1 hour Mon-Sat 8am-6pm. Reason: to allow limited access to businesses.
- 3. Church Street (Area R on map) section on south side between The Beacon car park access road and Butler Centre currently no waiting Mon-Sat 8am-6pm should become limited waiting for 1 hour Mon-Sat 8am-6pm no return within 1 hour. The north side could be considered for change to no parking (double yellow). Suggested No waiting within 5m of junction. Reason: to maintain traffic access whilst allowing limited access to businesses.
- 4. Mill Street (Area H on map) section on north side between Limborough Close and the pedestrian crossing, currently no waiting Mon-Sat 8am-6pm could become limited waiting for 30 minutes no return within 1 hour Mon-Sat 8am-6pm. Reason: to control parking which limits two-way traffic whilst allowing limited access to businesses.
- 5. Stirlings Road (Area E on map) for the section opposite the library which is currently no parking consider introduction of section of limited waiting for 1 hr no return for 1 hour Mon-Sat 8am-6pm.

20. Other business.


It was requested that the next planning agenda should include an item to discuss the need for additional car parking.

 - Holding objection. Would like to see the previous plans from planning application P21/V2460/FUL (which aren't available on the District Council's planning portal) to understand how the staircase will link with the existing flats.
- b) P21/V2872/FUL New covered pergola to garden with patio and festoon lighting. New patio with fixed seating and festoon lighting. Remove hedge and extend garden into 1no. row of car parking spaces. 78 Charlton Road Wantage OX12 8HL (The Nelson Public House) for Marcus Pope, Westgate Brewery.
 - Objection. Support the comments from the highways officer. Concerns about water runoff from the paved area and the on-street parking. Would like the applicant to consider the view from the road and the impact on the street scene.
- c) P21//V2237/DA Without listed building consent, taking down a curtilage wall; without planning permission, erection of single storey building within curtilage of listed building and within conservation area. (VE19/133). 22 Wallingford Street, Wantage.
