Town Mayor of Wantage**

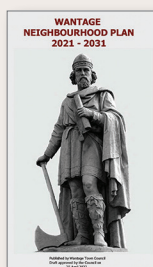

Updated Draft Wantage Neighbourhood Plan

The Town Council has finalised updates to the draft Wantage

Neighbourhood Plan. The original Plan was rejected by an inspector in 2016 relating to the proposed town centre and greenspaces policies.

The updated Plan has been modified to amend or remove the policies that were deemed unacceptable. All other policies remain unchanged from the document published in 2016 and the updated version of the Plan published and informally consulted upon in November 2020. No new policies have been added.

The Town Council is now proceeding to formal

consultations under Regulation 14 of The Neighbourhood Planning (General) Regulations 2012. This commenced on 1 June 2022 and will end on 14 July 2022.

The Town Council would welcome your comments and views on the various proposed policies. Responses to the consultation should be sent to the Town Council at its offices at The Beacon or email them to clerk@wantagecouncil.gov.uk.

The publication is also accompanied by an online survey that can be accessed through the Council's website. Paper copies of the Plan and the survey are available from Council Offices between the hours of 9.30am and 12.30pm on each weekday. The deadline for responding to the survey is Thursday 14 July 2022.

MARKET PLACE WESTERN END PEDESTRIANISATION

In support of the Town Council's proposal to permanently pedestrianise the western end of the Market Place (the area that is currently temporarily closed,

west of Barclays), Oxfordshire County Council has commenced a consultation titled **Experimental Prohibition of Driving & Waiting – Wantage: Market Place area**. The consultation can be viewed via web page <https://wantagecouncil.gov.uk/occ-consultation/>.

We know that many of you wonder what we do beyond our obligations, so henceforth we will include some items in the Newsletter, with the full list on the Council website, and also available on request from the Council office:

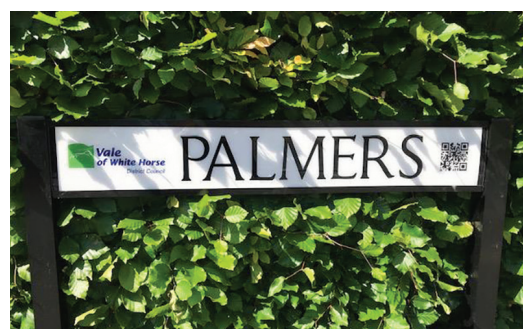
POLICIES AND PROCEDURES

- Wantage Council Mission Statement published in October 2021 – the full statement can be found on the website.
- Wantage Neighbourhood Plan 2021-2031 which has now been agreed by the Council. Currently the plan is at the pre-submission consultation stage – Regulation 14 of The Neighbourhood Planning (General) Regulations 2012 which requires that the plan is publicised and particular stakeholders given the opportunity to comment on it.
- Climate Action Plan – agreed by the Climate Emergency Committee, and which is on the Council's website. It is a 'live' document that can be amended.

ACTIONS TAKEN BY YOUR COUNCIL

- Appointment of our excellent Town Centre Manager and Project co-ordinator who have both greatly enhanced our management of town events and markets as well as relationships with town centre businesses.
- Consultation on the 20 is Plenty speed limit proposal – Currently our proposal is with County Council, who, if they agree to the plan going ahead will need to invite further consultation. We consulted residents via a survey advertised in our newsletter, website and social media. There was a good level of response – just under 400 responses. From this it appears that there is strong support for reducing the speed limits in the town centre and outside schools.
- Pandemic precautions – when the pandemic hit, your council acted very swiftly to provide safe spaces and signage to support social distancing, as well as providing financial support to groups helping those in particular need.

- Pedestrianisation of the West End, with installation of planters and benches. This was initially during the lockdown period but has been extended as part of the process of making it permanent. It is proving a really successful venue for markets, music and al fresco dining, or just somewhere nice to sit, on our new benches.
- To show appreciation for their support of the town during the Covid lockdown, we waived fees for our fantastic market vendors.
- Grants to local organisations (covered in a separate item in the Newsletter this time).
- King Alfred's statue has been cleaned.
- We have started replacing Street name signs.
- We are replacing and supplying new seating where needed.
- We are involved on the town's behalf, with national and regional consultations that affect our area such as Oxfordshire 2050 and active transport.
- As well as working on a new extension for the Cemetery we are opening up spaces, uncovering headstones and old graves. New waste recycle bins will be installed with new tree planting scheduled for the autumn.

AEDs/Defibrillators in Wantage

What is an AED Defibrillator?

An automated external defibrillator (AED) is an emergency life-saving device for use in the event of sudden cardiac arrest. It is a portable device that analyses the heart rhythm and administers an electrical charge to the heart if needed (to establish a regular heartbeat in the event of a cardiac arrest).



There are several AEDs located in Wantage including:

- **The Beacon**, Portway (Mounted on wall outside)
- **Wantage Fire Station**, Ormond Road (Mounted on wall outside)
- **Phone box** off the **Post Office Vaults** end of the Market Place
- **Wantage Memorial Park**, Manor Road, Toilet Block (Mounted on wall outside)
- **Wantage Library**, Stirlings Road (located outside the library)
- **Wantage Leisure Centre**, Portway (available in reception during opening hours)
- **King Alfred's Academy, Centre Site**, Portway (available in reception during opening hours)
- **King Alfred's Academy, West Site**, Challow Road (available in reception during opening hours)
- **The Bear Hotel**, Market Place (available in reception during opening hours)

- **Rockwell House Day Nursery**, Wallingford Street (in reception during opening hours)
- **Wantage Silver Band**, Reading Road (Tugwell Field on side of building)
- **Wantage Support Services** (Charlton village road on wall by main entrance)
- **Stockham Primary School**, Stockham Park (wall mounted outside the school)
- **Fitzwaryn School**, Denchworth Road (right side of reception outside main door)

Locations of community defibrillators can be found on the two national mapping services:

- **The National Defibrillator database** (www.nddb.uk), and
- **DefibFinder** (www.defibfinder.uk)

Neither give a complete UK picture, but together they represent about 99% of all known defibrillators. Defibfinder only shows the 10 nearest locations to your position.

— ACT FAST —

Only within the first few minutes following cardiac arrest will a victim be in a 'shockable rhythm'; rapid defibrillation is therefore vital. Placing AEDs in the community can dramatically reduce the time from collapse to defibrillation and can greatly improve survival rates.

Always call 999 Ambulance in an emergency and they will advise you what to do and the location of your nearest available defibrillator if it is required.

Always call from the patient's location. If there is someone available, tell them to go and collect the defibrillator. Never leave the patient on their own.

GRANTS TO VOLUNTARY BODIES

The Town Council is extremely pleased to support key Wantage organisations such as Vale Community Impact (formerly the Independent Advice Centre), Sweatbox and Wantage Museum, with substantial regular grants.

We have also awarded one off grants to a variety of local community organisations including Sustainable Wantage, Be Free Young Carers, Wantage Lifesavers

and various sports and arts groups. During the COVID pandemic we provided additional funding for children's laptops and free school meals to those in particular need. We supported the business community during lockdown by waiving tolls for the market traders who continued to provide for the town in difficult times.

Around 25% of our total budget is used to support these vital

activities many of which would not be able to operate otherwise.
